## Appointments to New Chancellor's Office Workgroups

### *Chancellor's Office Workgroup on Gender Equity*

- Convening this fall, the group is charged with evaluating current Title IX and related antidiscrimination policies within the California Community Colleges, considering the current state and federal policy landscape around this issue, and making recommendations for any legislative, budget, regulatory, or administrative policy changes our system may wish to pursue.
- The group is to produce a final report with recommendations to the Legislature “for establishing systemic campus reforms that effectively prevent, detect, and address sexual harassment on community college campuses,” as is required by [Assembly Bill 2048](#) (Fong), signed into law by Governor Newsom September 27, 2024.
- The goal is for districts to have the guidance and support they need to ensure our campuses provide a safe, welcoming, and inclusive environment for all students, faculty, and staff.

### *Focus Groups: Equity in Educational Tools and Services*

- Intention: In a co-design session, provide input into the development of Chancellor's Office internal evaluation processes to ensure that an existing or potential educational technology tool or service meets the required equity specifications as a part of the systemwide technology investment portfolio.
- This will include developing product certifications that measure and ensure equity throughout various competencies.
- Ten to fifteen faculty participants to be appointed by ASCCC
