There is limited funding for technology diminishing over the next 3 years, so we need to be strategic about our spending patterns. Financial details were explained. 6. Summer Classified Equity Institute	Victoria Rodriguez - The return of the Classified Equity Institute with Dr. Curtis Acosta this summer. The institute would run for 4 full days. I will send out a QR code and the link for the interest survey.
