CHAIR REPORT:

- Forms Revision & Diversity, Equity, Inclusion (DEI)
 - Dee shared that three (3) themes emerged from the recent forms survey:
 - Ask direct questions.
 - Provide checklists, especially for tasks to complete like CORs.
 - Incorporate DEI into the forms.
 - Committee reviewed an example from Las Positas for ideas on how to include DEI in curriculum forms. Discussion topics: consider a broad statement that may be more inclusive, include an open-ended option/question for DEI, and include a clear call to action for the form.
 - Other comments related to review of example from Las Positas: if listing groups, focus on groups we gather data about; consider incorporating DEI statement on/at each section for easy reference; who is determining what is "bias-free assessment"?; will marginalized communities be integrated instead of centered in the work? If so, what does that look like?
 - o General consensus: Checklist format with open comments and room for describing/explaining
- Curriculum Handbook Draft update Review Charge/Mission Statement and Composition
 - Dee shared the draft updates to the Charge/Mission Statement and Composition (Membership) for the Curriculum Handbook. Draft was partially edited/revised with the group during the meeting.
 - Action Item: Committee will review the revised Charge/Mission Statement and Composition (Membership) again at the meeting on April 20, 2021.

- Academic Senate Fall Flex Week Applications due April 30, 2021. Curriculum proposal will be submitted. Call for volunteers from committee to (a) work on the proposal and (b) prep/plan the flex week workshop.
 - Action Item: Dee will send out a survey to the committee seeking volunteers.
- Dave Dillon is joining us at the meeting on April 20th to share the draft DE Application updates. Question for Dave from the members: How to incorporate best practices for Inclusive Design into DE courses?
