5. Math Department Guests: Jenny VandenEynden and Susan Working

- A. Course Addition Proposals: MATH 082, 099NC, 171
 - Department chairs reviewed the math department flow-chart. Math 171 will be an optional innovative prep for calculus; however, this course does not automatically clear the prerequisite for calculus (Math 180).
 - The committee noted that Math 180L and 280L are missing from the flow-chart, but course deletion forms have not been submitted. The math department confirmed they are not planning to offer the 180/280 labs.
 - Math 099NC is proposed as a no credit support lab with an instructor present throughout the week. The lab will be open entry, open exit with an expectation of 10 hours of attendance for the term. The committee inquired how attendance will be tracked and it was suggested that students could use a Google form to check in and out. The committee will find out if there is a minimum amount of hours a no credit course has to be. The course will be graded as Pass/No Pass.
