The Department delivered a proposal presentation

- This certificate was created to support the growing student body from middle east, speaking to their interests and goals.
- The certificate was developed with an interdisciplinary focus.
- There are three required courses in the area of the middle east and three electives from various disciplines.
- Letter of Intent needs to be forwarded to impacted departments.
- The committee noticed an error in the course requirements list: Music 142, not Music 119 should be in the course requirements.
- Concern about not making ARBC 148 a required course for the certificate was raised. Citing that the voices and representation of the people of the middle east is

important and the course is taught through an ethnic studies lens. The department explained that Arabic 148 is not required, but optional to allow for flexibility in terms of scheduling. ARBC 148 is only offered once per year. They also explained that some people from the middle east don't identify as Arab, another reason why the course is optional. The committee pointed out that cultural perspectives could be explored through the other courses in the list: HIST 148 and MUS 142.
