4. Chair Report

A. Planning Goals

I. Common Course Numbering

- Course and program impacts (e.g. ADTs)
- Phase I is complete
- CIM will help us easily identify all the places where these courses live so we can modify those as needed.
- There are 17 courses to modify in phase 2 of CCN. These are done in 2 phases: Phase- II A due 9/10/25, Phase II-B due date 10/01/25
- Affected department faculty were given a PowerPoint with information and procedure to follow when updating their courses.
- Phase III-post-convening surveys by Sept 29.

II. Out of Date CORs

- In preparation for accreditation, we need to update outdated CORs. The Course Master List, located on the Curriculum website should be used to identify out of date CORs (in pink). CORs become out of date after 6 years, and should be updated on their 7th year.

- III. Programs & Learning Outcomes
 - Some of our programs are missing PLOs in our catalog. Tasks groups will be created for this work. There is a spreadsheet in the Shared Drive.
- IV. Standardized Attendance Accounting Method
 - We need to de-clump LEC/LAB course units. Dangling hours need to be increased to yield a unit, or removed. The deadline is 2028. We can lose funding if not completed. List is at the district. Vanesa will provide.
- V. Minimum Qualifications & Courses
 - We need to assign minimum quals by course, rather than by discipline. These are in large-part discretionary and college-specific.
- VI. Bachelor Degree Program – application filed for GC
 - On August 11, 2025 a BA in Cybersecurity program application was submitted to the Chancellor's Office. The CCCCCO will review and provide feedback. The next application period opens in December.
 - The curriculum committee will need to train for upper division review and approval if we get approved.

Target deadline for completion is September 30, 2025. Gainful employment for 2022-2023, quick turn-around of Oct. 1 for 2023-2024.
