AB 1705 is a Student Equity Initiative Mandated by Legislation and the CCCCO

- AB 705 was signed into law by the Governor in Fall 2017.
- AB 1705 was signed into law by the Governor in September 2022. This legislation mandates full compliance of AB 705.
- Funding and implementation timeline was driven by both the legislation and the CCCCO system office and not by administration at Grossmont College.

JAN 2018

Dev Ed Reform Bill: Two years to prepare for English & Math implementation and two years to innovate & determine best practices. Prep/innovation period ended in 2021.

English Department began process of eliminating developmental reading/writing courses. ESL was given an extension.

AB 1805

MAY 2021

As a condition for receiving Student Equity and Achievement funding, colleges must inform students of right to access transfer level coursework; colleges must publicize assessment results.

VALIDATION OF PRACTICES

NOV 2021

CCCCO Requires submission of proof of efficacy of pre-transfer level English & Math.

February 2022: VPAA, CPIE Dean, and SSE Dean meet w/Math Department to discuss CCCC0 intentions.

AB 1705

DEC 2022

Intended to resolve issues impeding full implementation of AB 705 by providing funding. Emphasizes that students must be placed directly into transfer level English & Math. CCCC0 Memo includes a paragraph on Enforcement.

AB 1705 IMPLEMENTATION

MAY 2023

Required funding plans for implementation be submitted to CCCC0 by July 1, 2023. No plan = no funding.
