Facilities Committee Report Out for Gymnasium Replacement

December 24, 2024

Detailed update and conversations that ensued on the project's status, scope, and timeline:

1. State Funding and Scoring Criteria

The project has undergone several Facilities Master Plan (FMP) revisions over the last two decades, and several funding application submissions to the state, with varying scopes, budgets, and scores. The project has been re-scoped multiple times to align with state funding priorities, which shift annually. In 2023, the project received approval for a Final Project Proposal (FPP), with a high score of 174. This allows the project to move forward with state funding support.

2. Project Scope and Timeline

The state approved plan includes the demolition of buildings #42 and #43, to be replaced by a new 23,140 sq. ft. gymnasium. The project is fully funded with a state contribution of \$11,218,047 and a district match of \$10,931,463.

Key project dates include:

- Preliminary plans start: 8/1/2025
- DSA final approval: 4/1/2027
- Construction completion: 6/1/2029

3. Task Force and Next Steps

A new task force will need to be established to guide the preliminary design phase, incorporating faculty, staff, and student representatives. The previous task force, which helped in earlier stages, included key stakeholders such as VP Marsha Gable and VP Marshall Fulbright. We will need to identify new members to ensure broad representation.

4. Next Actions

District and Gafcon will be soliciting architectural services through an RFP process and assembling a team for the IPBA (Initial Project Budget Analysis), which will address construction shortfalls, technology needs, and other impacts.

- Other impacts include relocation of the Custodial Department and ensuing costs, as well as swing space needs for Athletics and Exercise Science during construction.

Facilities Committee Report Out: Not to Move Forward With The Approved FPP Gymnasium Replacement

April 23, 2025

Detailed update and conversations that ensued on the project's status, scope, and timeline:

1. State Funding and Scoring Criteria

The Facilities Committee reported out the approval of the Gymnasium Replacement on December 4, 2024. The project was fully funded with a state contribution of \$11,218,047 and a district match of \$10,931,463. The project's rough cost total came in at about \$24m, which included additional SOW (Scope of Work) totaling \$30m, such as moving the custodial program that is attached to Bldg 43 and swinging the programs of Bldg 42 and 43.

2. What Has Changed

The total project cost is now estimated at \$55m

- The state contribution only increased to a total of \$15m
- The College is to bear the remaining cost of \$40m

3. Why The Increase in Cost?

- Escalating construction costs
 1. Projected construction costs, including labor, materials, project management, and market competition
 2. World economy and the market and industry rising costs and trends (LA Fires, Olympics, local competition)

4. Efforts Taken

- The District committed \$5m, leaving the college with \$35m
- Grossmont College conducted a budget and plan analysis
 1. College would be left with a financial commitment it does not have the capacity or resources to meet, which may impact future final project proposals and allocations
 2. College has other competing infrastructure and safety needs
 3. The college is responsible for the inflationary burden. The state will not adjust the amount they committed to with the FPP

5. Next Steps

- State deadline to inform the state by May 1 of our decision not to move forward with accepting \$15 million in state funds
- Passing on this current allocation by May 1 preserves the college's opportunity to seek future state FPP dollars
- Recommend to the College Council on April 24, 2025
- Continue to use Bldg 42 & 43 as intended. Bldg 42's life has been extended with the recent repairs and upgrades of the lower gym floor, ceiling, and HVAC

Updated SOW includes upper cabinets, chemical countertop, and the lower cabinets remain the same.



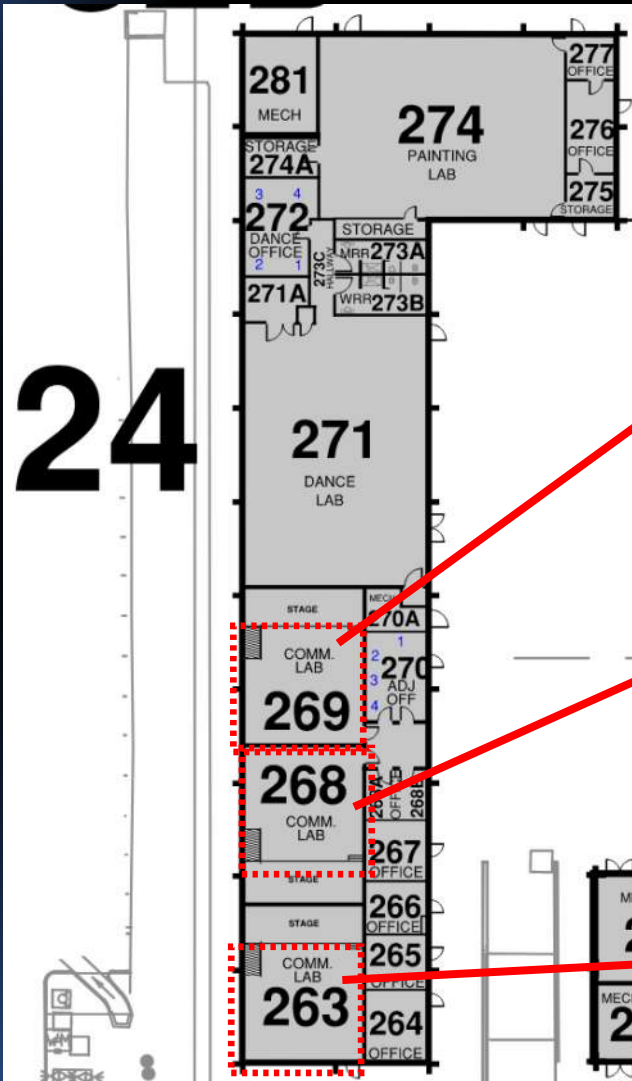

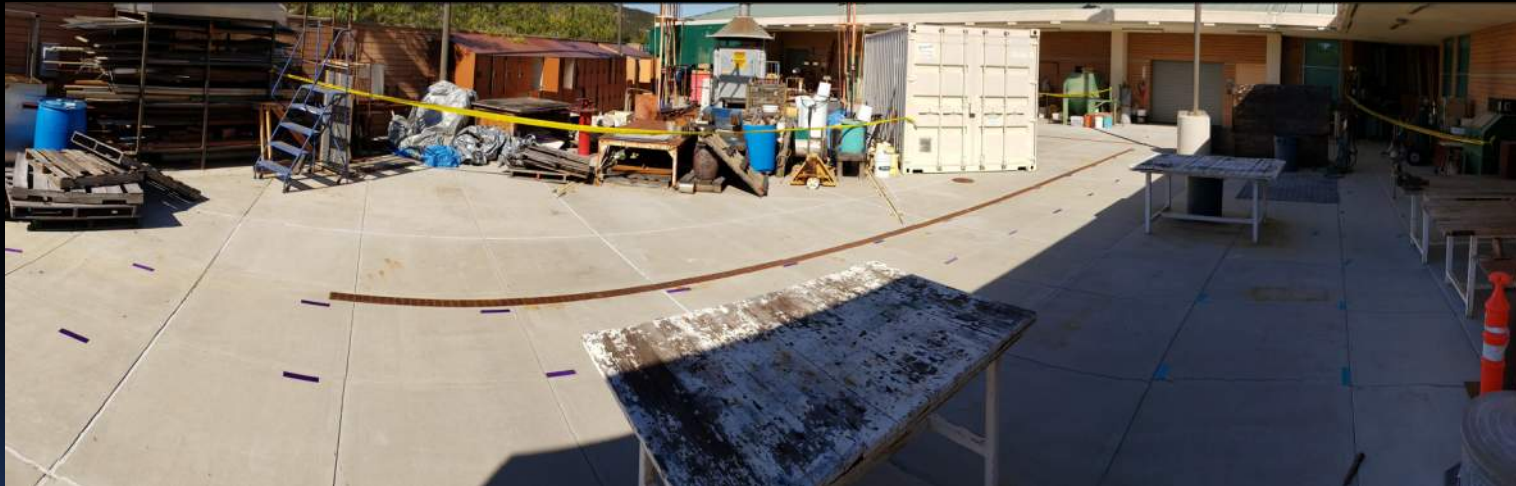
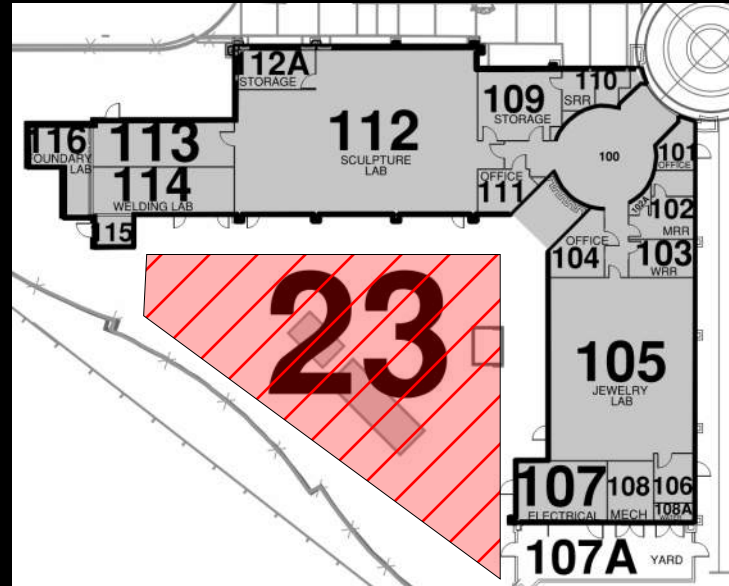
FPR 25-01 - Improve Three Classrooms



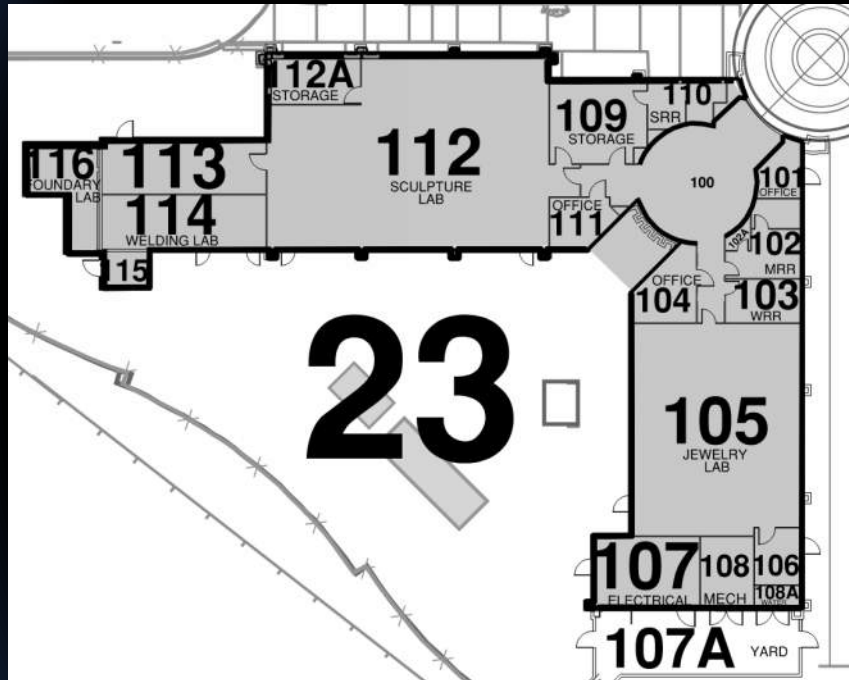
FPR 25-02 - Adjustable Stools



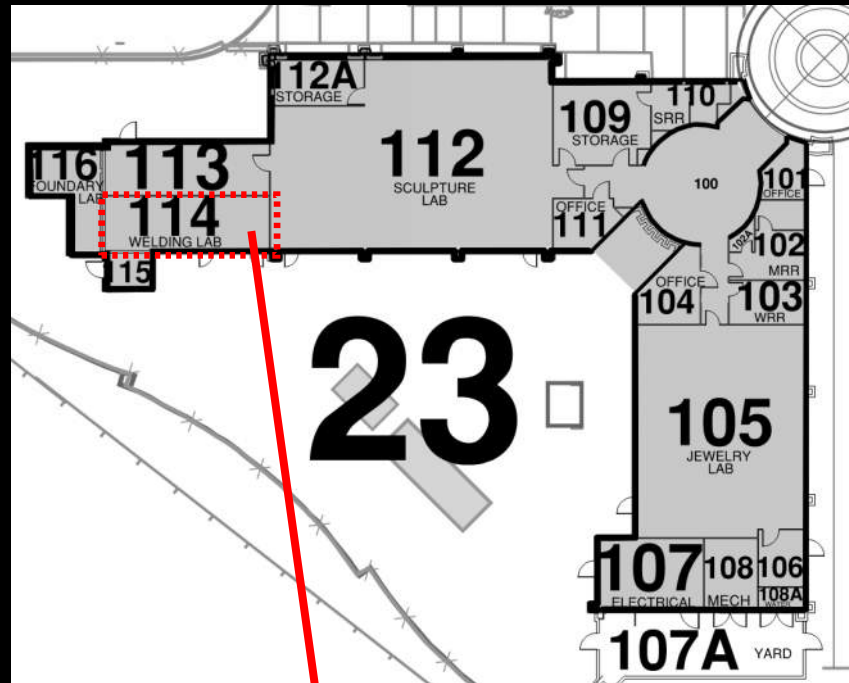
FPR 25-03 - Shade Sails



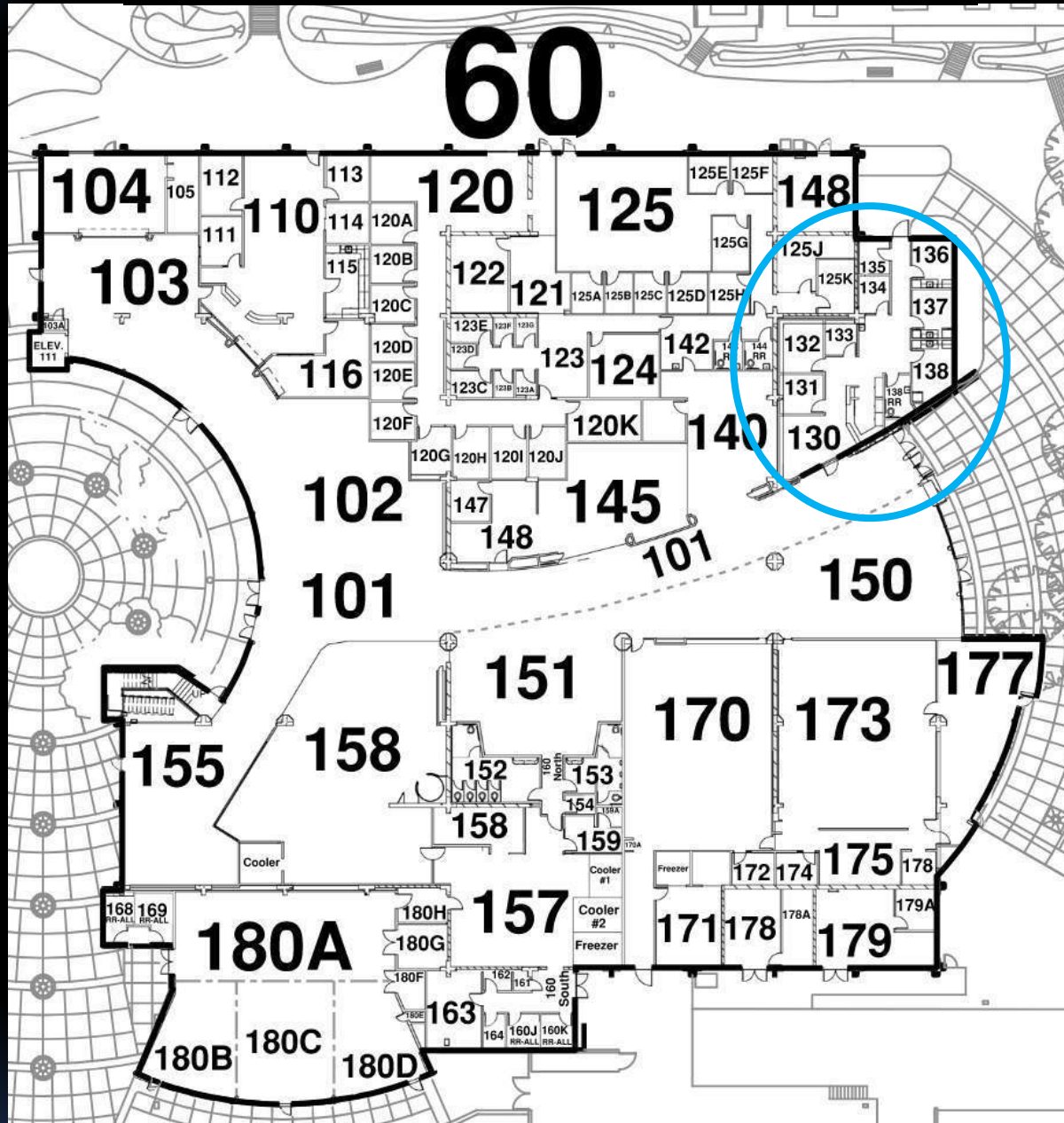
FPR 25-04 - Air Compressor

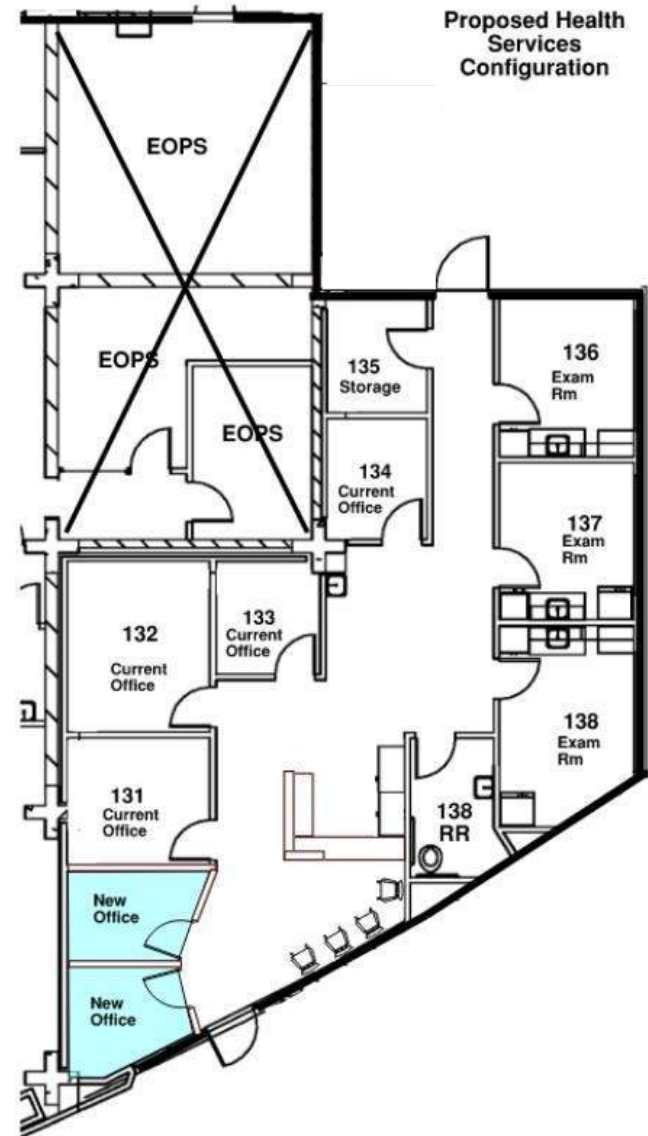
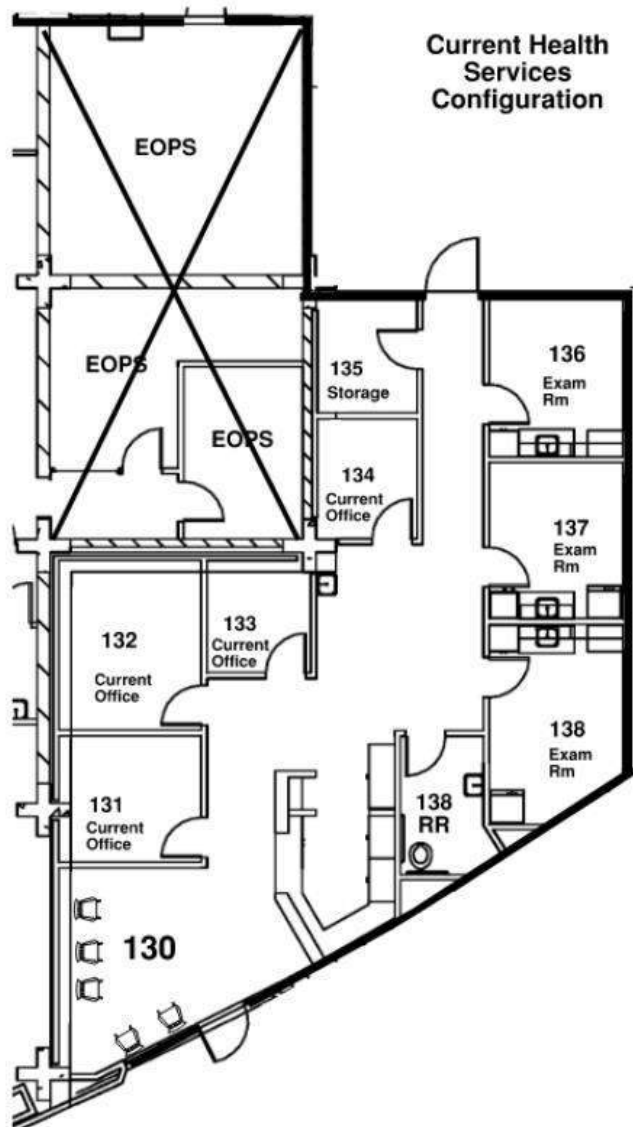


FPR 25-06 - Two Welders

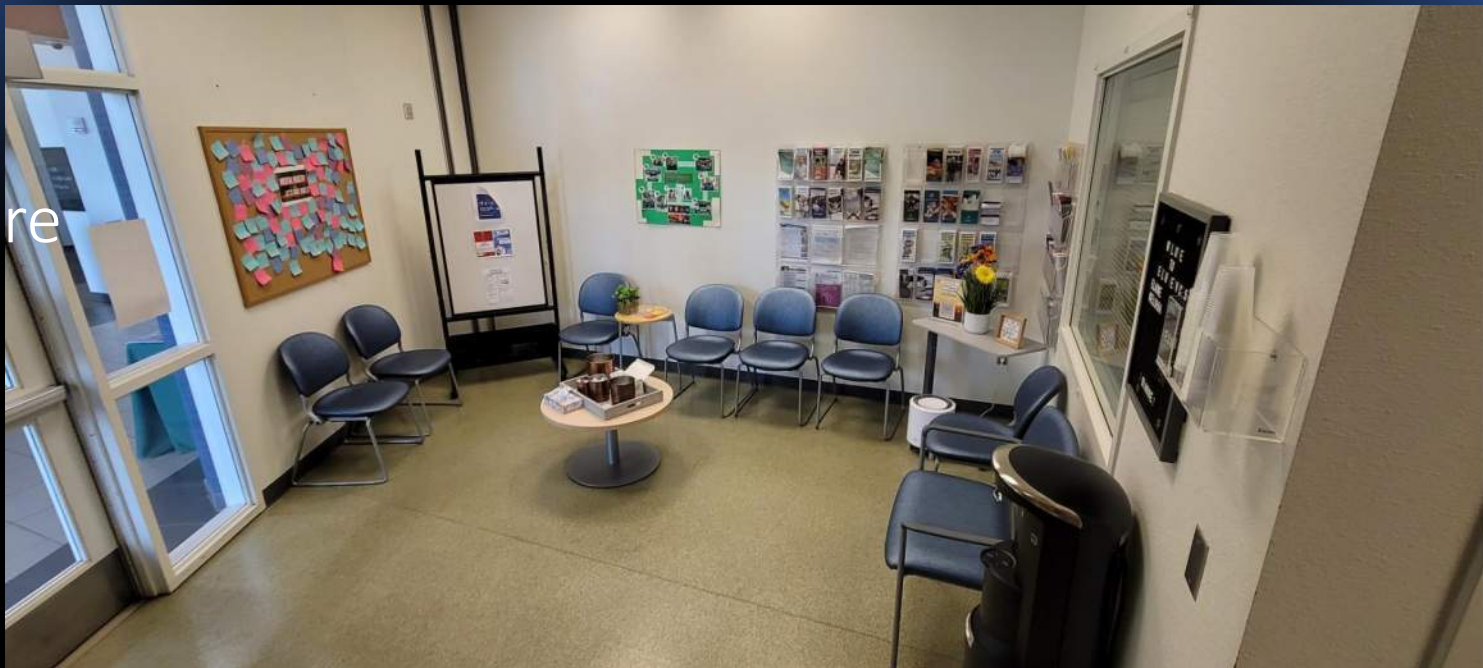


FPR 25-08 Mental Health Space

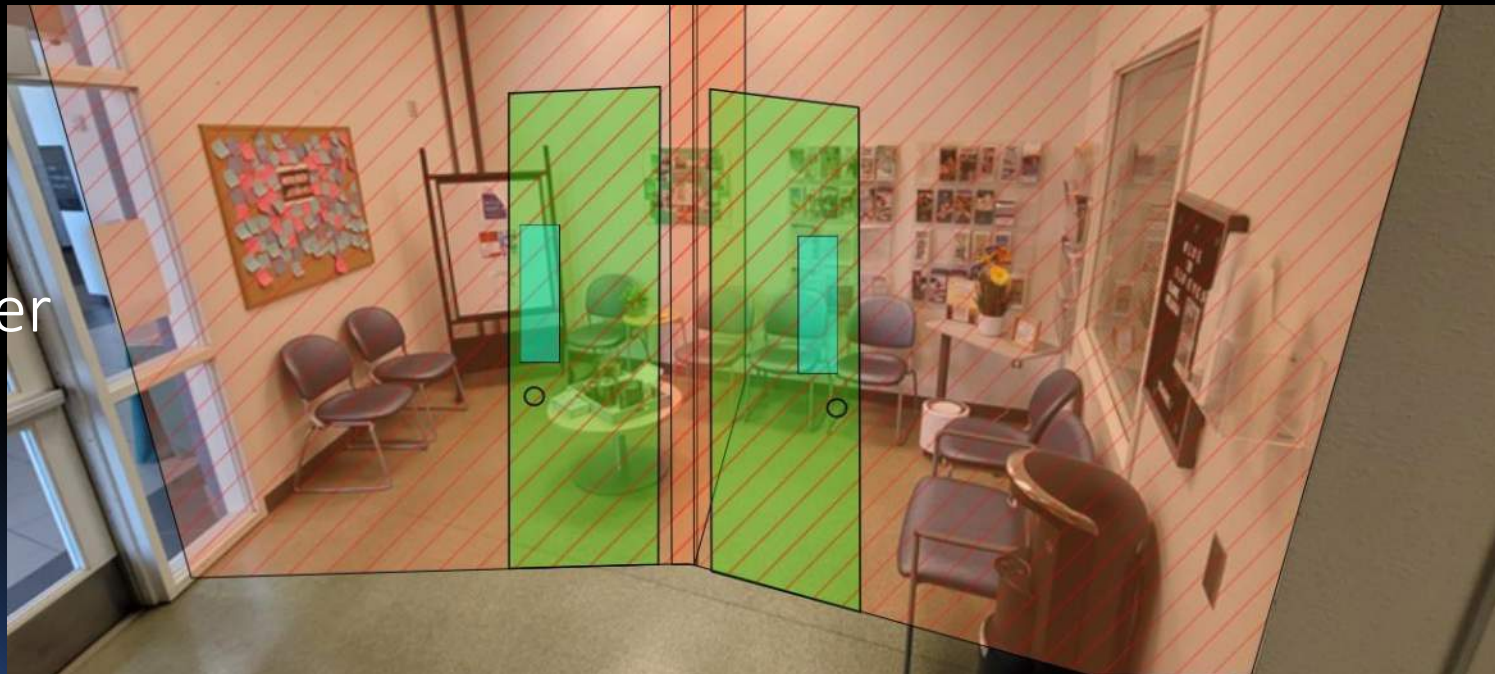




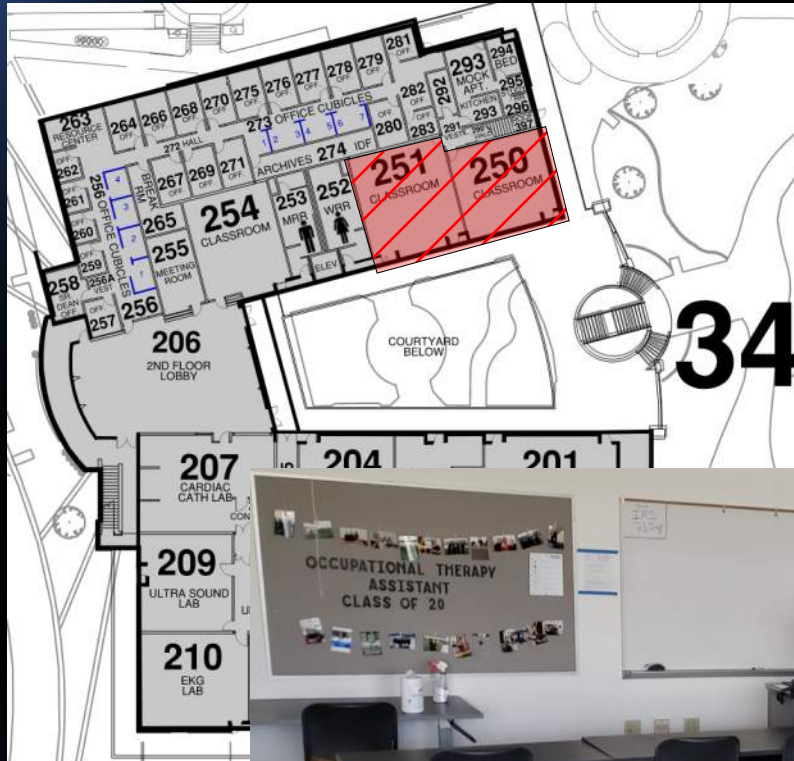

FPR 25-09 - Install Hard Flooring

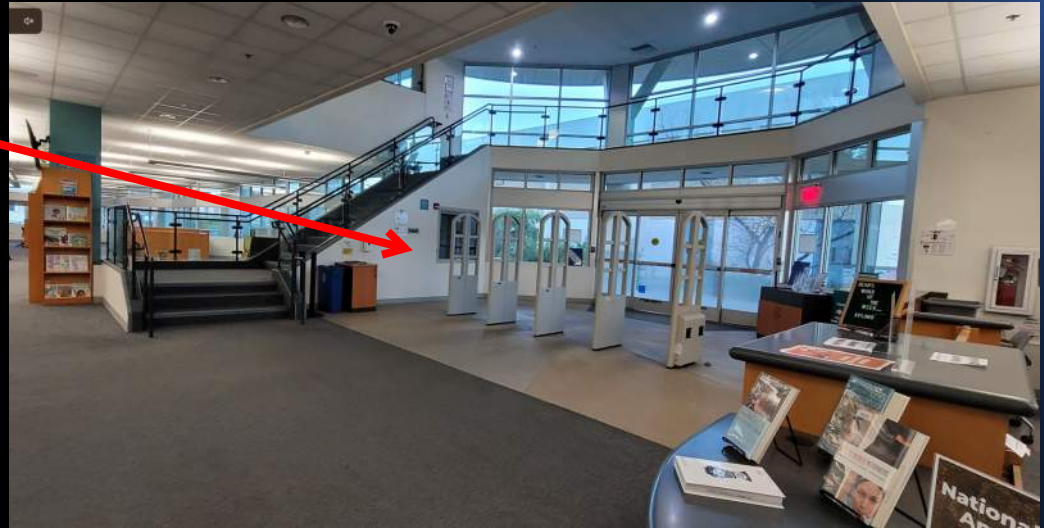


FPR 25-09 - White Boards for Chemistry

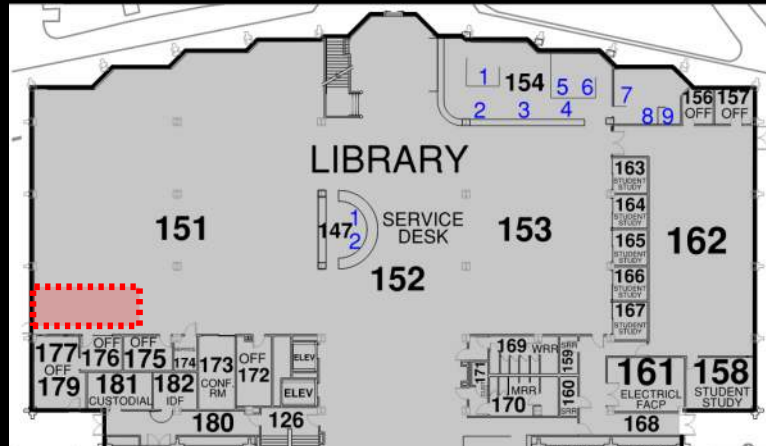

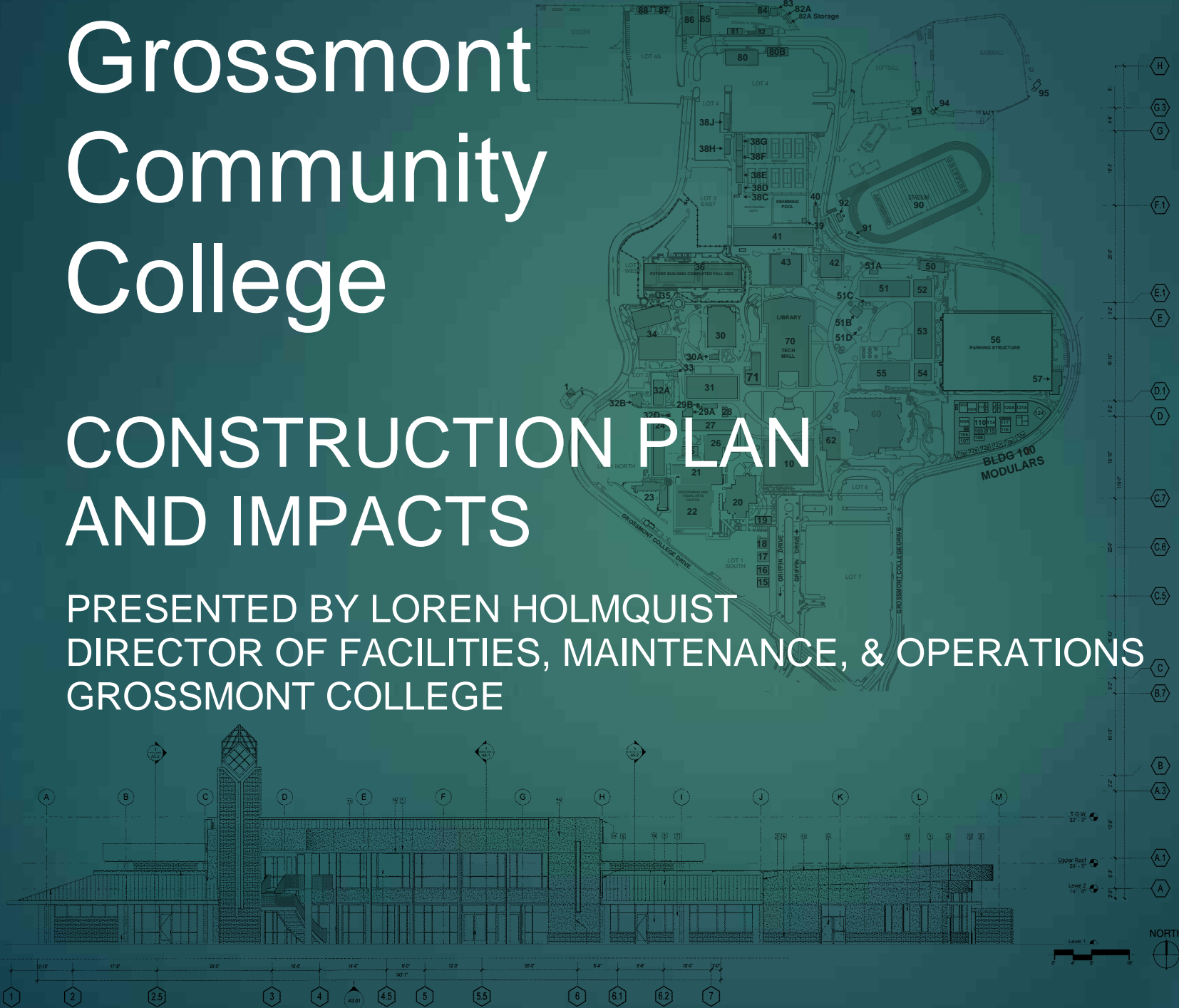

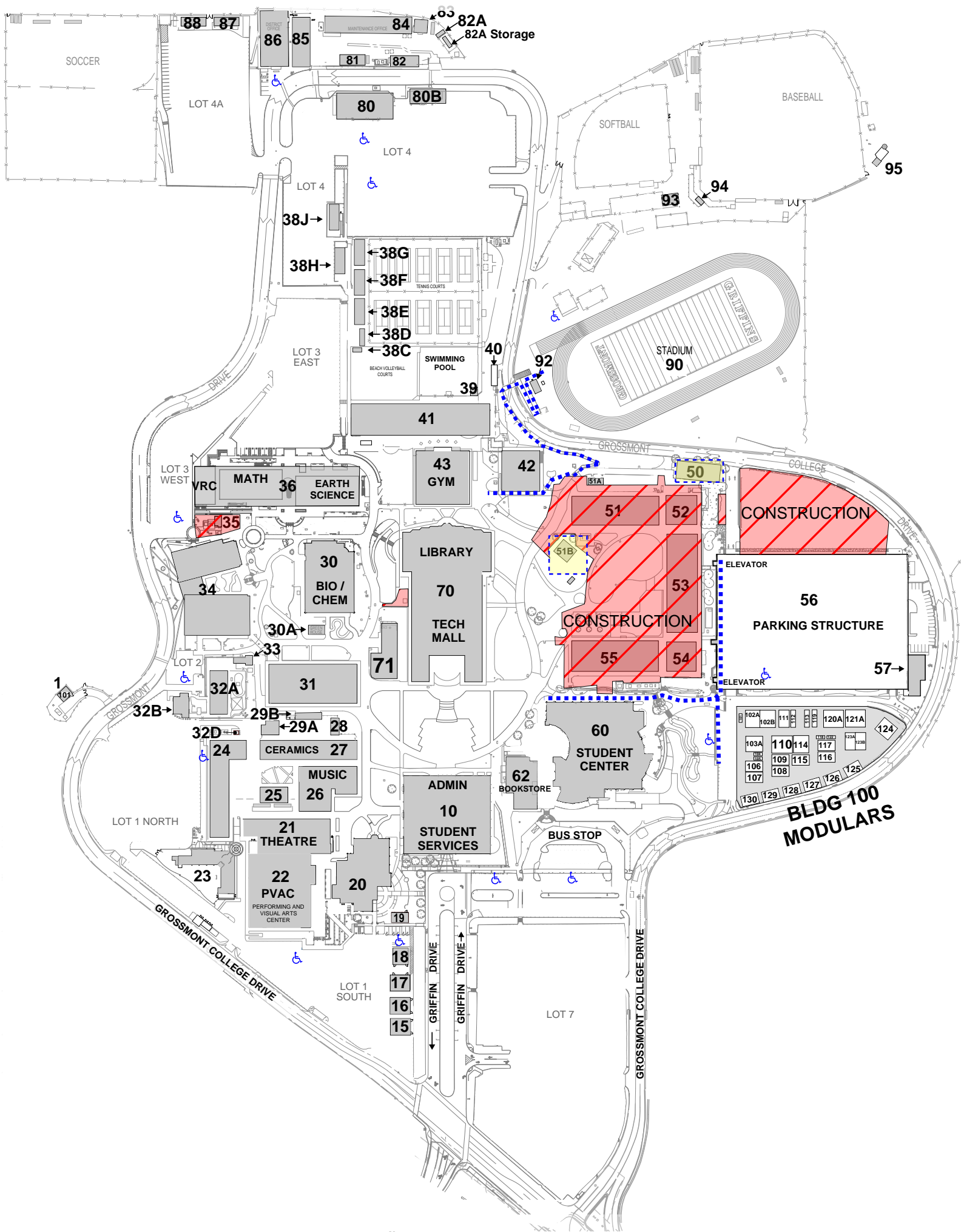
