Flyers have been created with information for students to phone in and Zoom into a Griffins virtual help desk which is operated by Student Ambassadors during business hours, Monday through Friday. Courtney will send all flyers to Cindy to distribute with the notes.</p> <p>Student Services hosted virtual Student Success Fairs on April 28th and 29th. The next Student Success Fair will be held on May 12 from 12:00- 2:00 pm. The focus will be on Commencement. A Virtual Onboarding, Super Saturday, was held on May 2nd. Approximately 60 to 70 students showed. The next Virtual Super Saturday will be May 30th.</p> <p>Outreach is currently working with FYE to host a Virtual Family Orientation.</p> <p>A&R is bracing for summer registration. There only form of communication with students is through email which is staffed by four employees.</p> <p>Students will only be able to take 8 units. Therefore, counseling will not be approving overload requests.</p> <p>Due to the high amount of pass/no pass and not drop, A&R requested Academic Senate to consider a modification major. Academic Senate supported this request and is working with Deans, Chairs and Departments to make the modifications to streamline the process.</p> <p>The International team is preparing a marketing plan with Lorena Ruggero to send to our local language academies.</p> <p>Barbara shared an article from Forbes.com Drop In FAFSA Completions Suggests Students Are Postponing Or Abandoning College</p> <p>Michael Copenhaver shared about the new Chatbot feature on the Financial Aid webpage. Students can ask Sam, the Chatbot, generic questions and it will answer them. FA currently loading more FAQs into the OCELOT program.</p> <p>Another section on the FA webpage is Emergency Grants.
